

#### RECOMMENDATIONS:

Not to be applied during periods of water stress unless when under irrigation.

To be applied during nutrition stress periods, as follows:

**Preventive treatment:** soil application before sowing, transplanting or beginning of plant growth. Apply with high water volume to facilitate the penetration of the product in the soil.

**Corrective treatment:** soil or foliar application with 250-400 L of water, repeat after 15 days if symptoms persist.

**Soil application:** 5-10 kg/ha before sowing, transplanting or beginning of plant growth.

**Hydroponic crops:** 2-3 g/100 L of irrigation water.

**Fertigation:** 2-3 kg/ha every 7-10 days during the crop cycle.

**Ornamentals (hydroponics/soil):** 5-6 Kg/ha per week.

**Foliar application:** 1 kg/ha/application in minimum of 1000 L of water when symptoms appear.

Field crops: 3 x 1.5 kg/ha before tillering stage, stem elongation and before emergence.

Forage crops: 1-2 kg/ha after each cutting.

Potatoes and root crops: 4 x 1 kg/ha at 7-10 days intervals, beginning at 10 cm stage.

Vegetables: 3 x 0.5-1kg/ha at 10-15 days intervals, beginning when foliage is sufficient.

Fruit trees: 3 x 0.5 kg/ha before flowering and 0.5 kg/ha after fruit set.

Recommended weather for spraying:

- To be applied during the first hours of the day.

- Foresee 3 to 4 hours without rain after treatment.

- Do not apply at extreme temperatures.

#### COMPATIBILITY

Compatible with most of the fertilizers and agrochemicals normally used. It's recommended to perform a test before mixing. pH stability range 4-10. To mix with calcium nitrate follow these steps: 1. Fill the tank with water. 2. Add Tradecorp AZ Bentley Plus. 3. Stir for 2-3 minutes. 4. Add calcium nitrate. 5. Stir again.
